Under AIFMD, the Company is required to calculate leverage under the two methodologies specified by the Directive, the 'Gross Method' and the 'Commitment Method'. The AIFM has currently set a maximum limit of 275% on the use of leverage based on the Gross Method and a maximum limit of 275% on the use of leverage based on the Commitment Method, which the AIFM considers consistent with the gearing limit set out in the Company's Investment Policy. As of 30 September 2022, the Company's leverage calculated using the Gross Method was 76.12% and using the Commitment Method was 100.04%.
